2018 FOOD VENDOR RULES & REGULATIONS

1. Vendor selection will be determined by the following criteria: A) Seneca Preference B) First paid first selected C) Number of available spaces dedicated to any one type of vendor.
2. All vendors MUST be enrolled in a federally recognized Tribe/Nation. Proof of enrollment required.
3. You must understand that filling out the application is just that...an application...not a registration form. Please do not consider yourself registered until notified as such. The onus is on you to find out the status of your application.
4. If your application is not accepted, the already deposited fee will be refunded via check.
5. NO CAMPING PERMITTED ON POWWOW GROUNDS. Free Camping/showers available at the Allegany Community Center: 777 Allegany Blvd, Salamanca, NY 14779.
6. We provide only a 20' x 20' space and access to water and electric. The Powwow Committee sells ice delivered to your booth. Cost is \$400 for vendors offering multiple food items. Cost of \$300 is for vendors who are offering only one type of item such as only dessert or some non-main dish.
7. Each vendor will be provided SIX weekend pass bracelets, and ONLY one parking pass. A \$10 fee will be charged for each additional bracelet above the allotted number per site.
8. A “Complete Application” consists of: completed application form, payment in full in U.S. funds (NO personal checks or cash), and proof of enrollment. The complete application deadline is June 22, 2018.
9. Dancers, drum groups, and powwow committee members will be given \$5 food vouchers. They are to be treated as cash (i.e. give change). When you close for business, come to the registration table to redeem your vouchers for cash.
10. A “Dancers/Drummers ONLY” line must be established (or congruent accommodations) during dinner breaks to ease their time constraints.
11. Signage: A sign must be created showing the dancers and drummers where their designated line begins as described in Rule # 10. You must conspicuously post your health inspection certification at your booth.
12. Once you are notified that you are selected to be a vendor, your registration fee becomes non-refundable. All fees are non-transferable.
13. We welcome \$20(+) value items/gift certificates as donations for Veterans prizes in the Veterans Welcoming Tent.
14. NO smoking, NO pets, NO drugs, NO alcohol permitted in the park.

SET UP

15. Pow Wow grounds will be open for vendor set up: Thursday 9am-7pm, Fri: 8am-1pm.
16. Grounds open to the public at 4pm Friday. Grand Entry is scheduled on Friday evening.
17. Only supply vehicles and utility trailers will be allowed to park on the perimeter of the food vendor area. Specific areas will be set aside for vendors. Parking map available in June on website.
18. ALL confirmed vendors must check in with Heath Garlow upon arrival for assigned spot by 11:00 am Friday.

19. Vehicles will not be allowed on the powwow grounds after 1pm on Friday. Safety First!!
20. You must provide your own power cord 12/3. All power cords MUST BE 16 GAUGE.
21. Vendors must provide their own NSP standard water hose.
22. Vendors MUST be set up and open for business by 10am on Saturday and Sunday.
23. All food vendors must comply with Seneca Nation Health System regulations. Inspectors will be stopping at each booth once a day. Non-compliant vendors will have an opportunity to correct violations, if any. If you refuse to correct, or are unable to correct, you will be asked to close.
24. Decisions regarding the vendor rules and regulations determined by the Powwow Committee are final.
25. Neither the Powwow Committee, nor associated partners and/or affiliates are responsible for lost or stolen items, personal damages or personal injuries which may occur during the powwow.
