2026 Non-Profit Booth Rules & Regulations

1. Vendor selection will be determined by the following criteria: A) Seneca Preference B) Number of available spaces dedicated to any one type of vendor C) Booth is dedicated to veterans' concerns D) First apply, first selected.
2. All applicants are subject to committee approval, and that approval can be revoked by the committee for any reason deemed necessary at any time before, or during, the powwow.
3. Raffle tickets are the only items that may be sold at a Non-Profit stand. This type of booth will require proof of enrollment.
4. No school organizations, Kindergarten through twelfth grade, will be allowed to sell raffle tickets or exchange money in any way.
5. Only three booths selling raffle tickets will be accepted. The rest will be informational booths.
6. Organizations applying to be an informational booth can be from any community, municipality, or interest (other than a public school).
7. Any non-profit organization that intends to sell anything (other than raffle tickets) cannot apply for a non-profit booth. The organization must instead apply to be a Craft Vendor or Food Vendor and are no longer subject to "Non-Profit Rules and Regulations" but rather become subject to the rules governing whichever type of vendor was applied for. If your organization wants to sell both craft items and food items, you must submit a separate craft vendor application and food vendor application with appropriate fees.
8. If you are planning to only set up for certain days, then please indicate the desired days on the application. This will increase the number of organizations that can be accepted.
9. Each non-profit will be issued two (2) complementary Vendor bracelets for weekend entry; these must be worn at all times. **Vendor bracelets cannot be used to register to dance/sing. If additional weekend access is needed, standard weekend pass bracelets are available for purchase at the admissions gates.**
10. **NO CAMPING PERMITTED ON CASINO GROUNDS.** Free Camping/showers available at the Allegany Community Center: 3677 Administration Drive, Salamanca, NY 14777.
11. We will provide a 10' x 10' space. You provide your own tables, chairs, canopy, etc. You are **REQUIRED** to bring weights to secure your canopy. (No stakes)
12. **NO** drugs or alcohol permitted at your booth.

SET UP

Powwow is 3-days this year. First grand entry will be on Friday evening.

13. **Vendor check-in and set up hours: Thursday, 9am – 7pm and Friday, 9am - Noon.** Vehicles are not allowed in the vendor area for more than one hour to unload and load **ONLY**.
14. Vehicles will not be allowed inside vendor booth areas once the public foot traffic begins. **SAFETY FIRST!** All vehicles must be moved to parking lot by **NOON** on Friday and by 9am on Saturday and Sunday.
15. No electric or water will be provided for Non-Profit booths.
16. Non-Profit booths **MUST** be set up and open by: 4pm on Friday and 9am on Saturday and Sunday.
17. Decisions regarding these rules and regulations determined by the Powwow Committee are final.
18. The Seneca Nation of Indians, Seneca Allegany Resort & Casino, Powwow Committee and any associated partners and/or affiliates do not assume responsibility for loss of property, property damage and/or personal injury that directly or indirectly occurs during or resulting from the events at the Marvlin "Joe" Curry Veterans Powwow.
